1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Sir Sayyed College of Arts, Commerce & Science is the minority institution in Aurangabad city established in 1990. It is the institution engaged in imparting quality education in the stream of Arts, Commerce & Science since three decades.

The college offer Arts, Commerce & Science at junior and undergraduate level. Postgraduate courses in Arabic, Urdu, English, Commerce & Chemistry are available. To meet the changing economic challenges, the college offer three years professional degree courses such as B.B.A & B.C.S.

The college has a long standing academic tradition and boasts of a team of 32 experienced, well-qualified and dedicated faculty with 21 research guides in English, Arabic, Sociology, Commerce, Chemistry, Physics, Computer Science, Botany and Zoology. The College has three research centres in Chemistry, Arabic & Commerce. 30 teachers are doctorates and 07 teachers have qualified SET / NET Examinations so far. 38 Students have stood in the merit list of Dr. BAMU, Aurangabad. Three students received gold medals in Arts and Science stream.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

- Sir Sayyed College of Arts, Commerce and Science, Aurangabad is affiliated to Dr Babasaheb Ambedkar Marathwada University, Aurangabad. The curriculum is designed and developed by the University. The college administers the curriculum recommended by the University. It offers undergraduate and postgraduate programmes in Arts, Commerce and Science along with some professional courses. The implementation of the curriculum is effectively carried out by the faculty through scheduled lesson plans and time tables decided at departmental meetings.
- Curriculum is dessiminated through lectures, Assignments, Presentations and Seminars.
- Practical application of curriculum is ensured through industrial visits and field work while the students also gain additional knowledge and updated information of the subject through Guest lectures.
- Bridge course and English crash course for the first year students ensures that Urdu medium students

and slow learners are brought to the required level equated with the rest of the class.

- The college has introduced 8 certificate and 3 value added courses for U.G students. These courses benefit the students with something extra beyond their regular activities. It helps students to perform experiments and to develop their skilled human resources which is required for industry. The courses in languages are helpful to empower the learners with necessary spoken and writing skills. These courses will be helpful for coping up with the increasing reliance on technology in our lives and in the world today.
- Extracurricular activities through different committees, Science and Girls Forum help students to gain knwwledge through applied learning.
- Cross cutting issues are adequately incorporated in the curriculum and through extension activities mainly NSS, the students are sensitized to various social issues affecting the society.
- Feedback system in the College helps the management and faculty to understand the effectiveness of teaching in the curriculum implementation. The students are encouraged to give their feedback on curriculum. The feedback gained from external stakeholders like parents, alumni and employers help to understand the need of the subject. It is uploaded on the college website.

Teaching-learning and Evaluation

- Full time Teacher students ratio is 1:41.7
- The ratio of temporary / full time teacher students in UG & PG is 1:19.06
- The college has highly qualified teaching staff.
- Out of 30 full-time teachers excluding the Librarian and Director of Physical Education, 29 teachers are Ph.D.holders.
- Seven teachers have qualified NET/SET Examination.
- The government has sanctioned 39 teaching posts based on the student strength of the academic year 2017-2018 and after that there is no revision of sanctioned posts. Out of those 39 sanctioned post, 32 full-time teachers including Librarian and Director of Education are recruited as per the existing State government norms.

- Students and teachers download research papers, notes, e-books online books since August 2022
- Weightage given to Class Tests, Assignments, Projects etc. in the overall development of students
- Guidance for Toppers and Slow Learners through Students' Core Committee and Remedial Teaching respectively.
- Grievances of students are addressed.
- College runs 05 UG and 05 PG Programmes.
- For each programme 3 5 POs and 5 7 COs are defined.
- Attainment of POs and COs has been assessed through two methods, Direct methods (Internal

examination, student feedback and google classroom) and Indirect methods (Bridge course, exhibition report, study tour, project report, student satisfaction survey, SL/AL identifier, MoUs and workshop).

- For last five years average result of the college is 64.06%.
- College conducts online/offline Student's Satisfaction Survey.

Research, Innovations and Extension

- IQAC and the Principal motivates and encourages the teachers to participate in the research work by encouraging them for minor and major research projects.
- Research centres in Arabic, Commerce and Chemistry. The college receives grants for 4 minor research projects. These projects were funded by Dr. Babasaheb Ambedkar Marathwada University, Aurangabad.
- The Principal scrutinizes the research perposals and Management gives its consent for submission of the proposals.
- The college encourages all the departments to hold seminars, conferences, workshops. In last 5 years,11 National and International conferences and Seminars were organized by the college on Intellectual Property Right (IPR) and Research Methodology. These workshops were held via online and offline platform.
- During last five years, 103 papers were published in UGC notified journals.
- Number of teachers published their books, chapters in books with ISBN number and articles published in proceeding are 71.
- The College has partnered with a number of prestigious organizations and industries to upgrade student's skills and competencies.
- The College has signed 22 MoUs and 04 linkages in last 5 years. It includes most of the reputed institutes of the region.
- The activities during last five years under MOU are 08 guest lectures, 01 historical visit, 02 industrial visits, 02 workshops, 01 seminar and 05 research publications.
- Activities like Swachch Bharat Abhiyan, Blood Donation Camp, Tree plantation, AIDS awareness, Health Checkup, Heritage Conservation, Voters Day Celebration, Samata Shanti March, Poshan Pakhwada, Seed Ball making, Samwidhan Day etc were organized by NSS unit of College.
- In the College there are some committees like Girls Forum, Health and Hygiene and ICC (Internal Complaint Committee) which undertakes different activities to make girls students self-reliant and brings awareness.
- Activities like Yoga day celebration, Gender Sensitization, HIV Awareness were also carried out.

Infrastructure and Learning Resources

1. Physical Facilities

- The College is well-equipped to facilitate the teaching and learning process.
- The total area of the campus is 7500 Sq. feet.
- There are 14 classrooms (04 are ICT-enabled), 05 laboratories, 02 Computer laboratories, 1 seminar hall.

- The campus is Wi-Fi enabled and classrooms are provided with LCD projectors, which facilitate technology-enabled teaching and learning with software and computer configuration updated regularly.
- Safety and security of infrastructure is ensured through 24/7 CCTV surveillance.
- Fire extinguishers are placed in prominent areas and refilled on a regular basis.
- The UPS back up of 5 KV generator is available.

1. Library as a Learning Resource

- College has library equipped with cloud based LIB-Man software, an integrated multiuser and timetasted software for complete computerization Library.
- Total collection of books is 11465 (8501 Titles),332 Bound Volumes, 11 Journals and periodicals and 13 newspapers.
- Volumes of Encyclopedia Britannica is available in Library
- There are separate reading rooms for girls and boys.
- N- List facility also is subscribed in August, 2022 to provide access to e-resources of N-List

1. IT Infrastructure

- College has a total 58 computers:23 in Computer Department, 10 in IT Laboratories, 5 in Science Departments, 6 in library and 10 computers for administration work.
- All the computers are connected in Local Area Network (LAN) & Wi-Fi
- LCD projector is available in Department of Physics, Zoology, Chemistry, Microbiology & Commerce IT Lab.
- The internet connection was upgraded from Broadband line (100 MBPS) to leased line of 100 MBPS Unlimited on 1 December 2022.
- For attendance of teaching and non-teaching staff, bio-metric machines is available.
- The website of the college is administered and updated regularly by the Department of Computer Science.
- College administration software is purchased in 2022

1. Maintenance of Campus Infrastructure

- The college ensures that the infrastructure facilities are regularly well maintained and updated to enhance better physical, academic performance.
- The maintenance work is carried by proficient in-house staff.
- A separate team of employees have been appointed who take care of the campus cleanliness and hygienic environment.

Student Support and Progression

The college is committed to its mission, "Humane Citizen through Education", hence the college is dedicated to

impart quality education with all round development for economically weaker strata of the society especially Girls.

- Besides the Government Scholarship, the college also provides financial assistance to economically deprived students in terms of concession in fees, installments, fee waivers and Student Aid Fund.
- During the assessment period 2473 students received sum of rupees 6018254 through Government Scholarship. The sum of rupees 155800 was distributed among 305 students through teachers contribution of rupees 1500 per head every year under Student Aid Funds. (SAF)
- 1013 students were benefitted by Skill Enhancement Programmes such as
- i) Spoken English
- ii) ICT
- iii) Computing Skills.
 - Health and Hygiene of Girl students is the priority for which the college organizes various awareness drives and camps.
 - Through Career Counseling and Guidance, 799 students were benefitted during the last five years.
 - The college has transparent mechanism of settling the grievances. Students are free to raise their complaints under Internal Complaint Committee (ICC).
 - Discipline, Anti-Ragging and Grievance Redressal Cell strictly monitors to maintain the Ragging free campus
 - During the assessment period 106 students progressed to higher education and 22 were placed in various sectors since 2017-18.
 - During the last five years 1222 students participated in various outdoor and indoor games at Inter and Intra-college level.
 - The college has received Runners up Trophy for Intercollegiate Football Tournament in 2017-18.
 - The registered Alumni of the college is scattered in almost every avenue of the society and contribute significantly to the development of the institution through generous donations, organizing activities and providing financial and logistic support to various programmes.

Governance, Leadership and Management

- Governance, Leadership and Management emphasizes on participative management with decentralized decision making at all levels and flat organization structure.
- Council of Heads along with IQAC looks after various issues related to curriculum planning and its implementation.
- More than 23 college committees/bodies and cells with participation from all stakeholders. Regular stakeholder meetings are conducted for decisions making and implementation of action plans: such as department meetings, meetings of CDC and committees.
- Strong perspective plan built on 7 pillars Curriculum, Teaching, Learning & Evaluation, Research & Extension, Infrastructure and Learning Resources, Student Support, Management, Distinctive Practices together contribute for achievement of the College Vision and Mission.
- Implementation of e-governance in areas of planning and administration, admission, examination, student activities and finance enhance good governance.
- Sir Sayyed College Staff Credit Cooperative Society a registered-body looks into the welfare activities

such as financial needs of the staff.

- Strict adherence to the policy and rules and regulations regarding recruitment, selection and career progression of the teaching and non-teaching staff.
- On an average 31 % of the faculty attended online/offline FDP and orientation /Refresher courses during last five years.
- 18 % of the faculty were provided with financial support to attend conference, workshop and to obtain membership in professional bodies.
- The College has conducted 16 administrative and professional development programmes.
- The College conducts financial audits at three levels internal, external and government.
- The main quality initiatives institutionalized by IQAC are promotion of Online Learning through NPTEL, SWAYAM, IBM, etc. and establishment of Avishkar Cell for Promotion of students skills'.
- Efforts of IQAC have resulted in positive outcomes in the form of more number of collaborative activities i.e. 22 collaborations and MoUs for joint academic and research activities.
- Feedback mechanism for academic activities and support services.
- Timely promotion of teaching and non-teaching staff.
- The IQAC has played a catalytic role in enhancement and sustenance of quality by framing the policies, by developing a perspective plan and by initiation of quality measures regarding NEP 2020.

Institutional Values and Best Practices

- Topics related to gender are incorporated in the syllabus of undergraduate course (B A).
- Moreover, project work related to gender is assigned to third year students in History and English and Sociology.
- The college has an Internal Complaint Cell which conducts some activities to address the issue of gender equity.
- o Girls' Forum of the college also addresses the issues of women.
- Safety and security of the girls is ensured as the CCTV cameras are installed in classrooms, campus etc.
- Common room for girls is also provided.
- Physically handicapped students are provided with sitting area in the lounge.
- Dustbins are kept at various places for disposal of solid waste. Papers and waste are segregated.
- Solid Waste is given to the specially designated vehicle of Aurangabad Municipal Corporation for collection of garbage.
- Morever, notices regarding environment and energy conservation are circulated.
- The management ensured that the staff employed hailed from diverse regions and belong to diverse cultural and linguistic background.
- In undergraduate course of Arts, students from Madarsas opted for Arabic and Islamic studies. Some of these students later pursued Masters degree in Arabic.
- Most of the students who belong to different communities were given admission in M.Sc. Chemistry.
- Hindi, Urdu, Arabic and English were offered as second languages to be studied at undergraduate programmes.
- Cultural committee organize various programmes to promote linguistic and cultural diversity. Various activities promoting Constitutional values are conducted.
- Handbook of Code of Conduct is a manual prepared by IQAC and Discipline Committee ensure its implementation.

- Spoken English Crash Course and Students' Aid Fund are two best practices implemented by the college.
- Spoken English Course ensures that Urdu medium students gain basic proficiency in English. Students' Aid Fund helps the financially weak students to continue education.
- Keeping in mind the vision of the institute, its priority in imparting education to minority students and its thrust on women education, SAF play a crucial role.

1.1.1 The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

Sir Sayyed College of Arts, Commerce and Science, Aurangabad was established on 23rd September 1989 and is permanently affiliated to Dr.Babasaheb Ambedkar Marathwada University, Aurangabad. It follows the curriculum prescribed by this University.

In accordance with the Academic calendar provided by Dr Babasaheb Ambedkar Marathwada University Aurangabad, the Institutional Academic Calendar is prepared at the beginning of the academic year. The Principal monitors the overall activities in general. The time table committee prepares the time table in such a manner which ensures that all the subjects are given equal and proportionate weightage so as to effectively deliver the contents. The timetable is displayed on the college notice board. The proper course allotment and workload distribution is done by Heads of the Department. At the start of the academic year, a week-long Bridge Course is conducted for First Year students. This course enables them to cope with the new syllabus. The curriculum, reading materials, question papers pattern is provided to the students through offline as well as online mode by the respective subject teacher thereby helping to boost the student's morale and confidence.

Use of ICT tools improves the learning process. This subject information is shared with students on What's app groups and through Google classroom. Teachers also guide students in virtual classrooms thereby enhancing the curriculum deliverance, especially to mention it helped tremendously in the pandemic period. Diaries are maintained regularly and monitored by the HODs and Principal.

Students are instructed to complete record books after performing the practical. As part of continuous evaluation, every teacher is directed to conduct class tests per semester. After conducting the test, answer papers are assessed and returned to the students for their future reference. The students are asked to give seminars on topic of their own choice. The seminars are conducted in all the faculties thereby helping the students to explore and gain more information about the subject.

At the end of the semester, the syllabus completion report is given by all the teachers. It is checked by the Heads after completion of the syllabus. A number of teachers represent themselves in Academic Bodies thereby contributing to revision and improvement in curriculum of the affiliating University.

In extracurricular activities, programmes are conducted through the NSS unit and also other committees of the college.

IQAC of the college takes feedback on curriculum and different stakeholders of the college and communicates it with the respective Teachers, Principal and Management and affiliating university for appropriate actions.

In teacher learning process student centric method such as the participative learning, experimental learning and problem solving methodology such as enhancing learning abilities by using ICT lectures. In participative learning department of Botany and Zoology organize the industrial tour of student to the Agricultural University. Department of Computer organizes the Hardware training to the student which enhances their hands on training experience and future used as job experience. Department of Zoology organizes the model exhibition to the student. Department of Physics and Electronics organized training for student to prepare electronic equipments, kits and model. Finally the Department of Chemistry organizes quiz competition and poster presentation competition to enhance the skill and knowledge of student in their domain. Most of the teachers used Zoom online app for delivering lectures online during certain period of time. Some teachers also delivered online guest lectures organized by the different institutions. Some teachers attended the online refresher courses organized by SWAYAM-ARPIT.Some of them also attended the courses on core subject as well as interdisciplinary subjects organized by NPTEL.Online training programs on IPR and research methodology were also attended by certain faculties.

Research supervisors of the college arranged online interaction and viva-voce of their research students. Google classroom was created by most of the faculties. Notes were uploaded in the goggle classroom. Even assignments were given to the students in the goggle classroom. Tests were also conducted on goggle forms as well as Testmoz app. The college also has its own YouTube channel. Different programs

are video recorded and uploaded on this channel. Teachers also created whatsapp group of the classes they engage. Students are provided all kinds of information on the group such as date of examinations, schedule of examination date and venue of the different activites and programs organized by the college are also notified in the group. The college also has its whatsapp group of teacher's. Different notices and circulars are circulated in this group. 2.5 Evaluation Process and Reforms

2.5.1 Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

Students are informed about the internal evaluation structure and its importance at the very beginning of every academic year. Internal evaluation has been given weightage in the overall academic development of the students. The Formative Assessment comprises of Class Tests, Assignments, Projects, and Industrial Tours etc. The Class tests are conducted in both the semesters. The Teachers interaction, lectures and practicals enable the teachers to evaluate the performance of the students and identify the learning gaps if any. Students are selected on the basis of their performance and toppers are guided through the Students Core Committee while slow learners are given remedial coaching. Active participation of the students is encouraged through group discussions. The components of practical examinations include the Record maintenance and Viva voce. All these internal evaluation attempts to improve the overall knowledge and personality of the students.

The College has an effective, transparent, and organized mechanism to address the examination related grievances. The entire mechanism focuses to support students in a fair and impartial way. There is an Examination Grievance Committee which looks after the grievances related to the examination and evaluation in the college. Any grievance coming from any stakeholder is placed before this committee and resolved in a transparent and efficient way

The candidate who appeared at the university examination can apply to the University for Verification of marks of his answer books through college within a period of 10 days from the date of declaration of the concerned examination results. The result of the verification of marks is communicated to the candidate concerned, within a period of 30-40 days. There is a provision for revaluation of the answer sheets. The students can get photocopies of their answer sheets by depositing the required fees to the University through college.

If an examinee is not satisfied with the marks awarded to him/her, he/she may challenge the same by applying to the university through the Principal in the prescribed form within 8 days from the date of issuance of photocopy of answer book by the university.

Grievances of the students such as, incorrect entry of marks, queries related to subject codes/programs, wrong entries in names, hall tickets, absenteeism, etc. are addressed in stipulated time by the college to the university. Internal examination marks of various subjects are filled and submitted through the Online Portal of the University. The college appoints the Internal Squad to prevent malpractices in the examination hall at the time of examinations. Mobile Phones in the examination Halls is strictly prohibited. CCTVs Cameras are installed in the examination halls to ensure transparency of the examination process. University examination-related grievances like with withheld results, Mass failures, non-receipt of mark lists, and so on are communicated through the Principal to the Director, Board of Examination and Evaluation of Examinations, Dr. Babasaheb Ambedkar Marathwada University

The assessment tools and processes used for measuring the attainment of each of the Programme Outcomes and Program Specific Outcomes and Course Outcomes areas are as follows:

POs and COs are evaluated in following manner,:

1. Two unit tests and one tutorial assignment are given in each semester. The questions in the unit tests and tutorial, assignment are as per COs of respective course. The questions for unit tests and assignments are framed in such a way to cover maximum course outcomes. Assessment is done regularly. The final attainment for each COs under direct assessment is calculated by taking average of the COs attainments from Internal Examinations and Assignments.

- 2. **Practical Examination**: For B.Sc. practical examination external and internal examiners are appointed for evaluation, and based on the evaluation of internal and external examiner outcome is measured in terms of marks.
- 3. **Project evaluation and Comprehensive** *Viva-Voce* **Examination:** For B. A. Programmes as per the university guidelines project are being assigned to students and after completion of project external examiner is appointed for evaluation of project through viva-voice examination. While B.Com. (IT Practicals) and B. Sc. Computer Science, performance of the students in practical exam is assessed and Viva-voce is conducted during practical examination.
- 4. The program outcomes and Program Specific outcomes are assessed with the help of course outcomes of the relevant courses through direct and indirect methods.
- 5. The teaching-learning and assessment processes are reviewed by IQAC through Academic and Administrative Audit. It includes an external peer team member. Records of academic results and other achievements are maintained by the departments or the units. They are submitted to the IQAC at the end of academic year.
- 6. The feedback obtained from students, teachers, alumni and employer on curriculum, teaching and learning helps to understand the expected learning outcomes. Secondly, the students overall performance in co-curricular and extracurricular activities as well as his/her behaviour on and off the campus help to judge the programme or course outcomes. The college tries its level best to inculcate above mentioned outcomes.

1 Spoken English Crash Course

Goal: The course aims to enhance student's language proficiency. In an age of globalization, English language competency and communication skills have acquired great significance. English language skills and communication skills are prerequisites for better employment. The course intends to equip the students with these required skills to increase their employability. The course aims to instil necessary confidence in the students so as to enable them to speak and write in English fluently.

Context: Most of our students come from Urdu medium. They find it difficult to speak in English fluently. They even find it difficult to grasp the subject knowledge. In the background of this scenario, the Department of English took the initiative to start this Spoken English Crash Course for the students weak in English. The course instils the necessary confidence in the students.

Practice:

Spoken English Course is an innovative practice of the college especially for the benefit of the students. The course is designed by the Department of English. Required emphasis and weightage is given to units

such as grammar, phonetics, communication skills etc. Faculty of English organizes the programme and engage lectures. Schedule of the course is displayed on the notice board and the students are informed accordingly. Prior to the course, students were asked to speak on few topics in the respective classes by the respective English teachers. Intrested students attended the course.

Evidence of Success:

Some students attended the ten days Spoken English Crash Course. After the course, students were given some topics to speak so as to test their speaking skills. It was observed that their speaking skills improved drastically. They were able to converse in English with confidence.

2 Student Aid Fund (SAF):

Goal:

The College has established Student Aid Fund to support poor and needy students. Deserving students are helped financially to pay the admission fee. This is to ensure that no student is deprived of education for want of money.

Context:

The College is located in a predominantly Muslim area, which is socially and economically backward. The parents of the students belong to low income strata, hence find it difficult to provide good education to their wards. Apart from Govt. EBC support, the teacher and management of the college personally contribute to the Student Aid Fund. This fund enables the students to pay their fees also.

Practice:

The College appointed In-charge of Student Aid Fund. Students applying for the benefit of SAF must satisfy following criteria: a) Students should be economically backward. b) They should apply in prescribed format for SAF. c) 75% attendance is compulsory. d) In-Charge reserve the right to verify the claims of an applicant. In-Charge of SAF scrutinizes the application and provides help to the deserving students.

However, it faced some challenges and found that most of the students were not able to complete their education due to poor financial condition. The parents of the students belong to low-income strata; hence find it difficult to pay the fees. Considering the large number of students, even Govt. scholarships were not enough. In this backdrop, the teacher and management came forward to help number of deserving students, especially girls. The college established 'Student Aid Fuond' to support poor and needy students. Deserving students are helped financially to pay the admission fees. This ensures that no student is deprived of education for want of money. This fund enables the students to pay the exam fees also. This probably also helps in checking the drop-out rate of the students.

Students applying for the benefit of SAF must satisfy condition decided by the committee. The decision of the Principal and In-Charge of SAF is final regarding grant of concession in fees to students.

Every year, good number of students belonging to different streams availed the benefit of SAF.

Keeping in mind the vision of the institute, its priority in imparting education to minority students and its thrust on women education, SAF play a crucial role. Otherwise, most of the students, particularly girls would not have completed their education.
